# Cyprus - EU fast track citizenship and passport by investment

The process

**Step 1:** Documents are translated to English and certified

Step 2: Select properties in Cyprus by visiting Cyprus or via correspondence.

Sign purchase agreement and transfer funds into escrow account. Receipt is

issued, which is required for the application

Step 3: Payment of submission fee of €2,000 per adult. Application is lodged,

together with purchase agreement and all supporting documents, at the Ministry

of Interior

**Step 4:** Citizenship approval from the Ministry of Interior within 3-4 months.

**Step 5:** Applicant (and spouse) must visit Cyprus within 3 months of receiving approval to affirm faith to the Republic of Cyprus in the district court and to collect their passport(s) and identity cards(s)

**Step 6:** Submit application for children to be naturalized. Applications for minor children are processed within 3 weeks; they can visit Cyprus anytime to collect their papers. Adult children applications are processed within 2 months and are subject to  $\{0.000\}$  submission fee and approval fee of  $\{0.000\}$ . Adult children must visit Cyprus within 3 months of receiving approval to make the necessary oath and collect their passport and identity card.
